# **Environmental Policy Statement**

## Statement of Intent:

Each evo Group company will operate with the following key environmental objectives:

### To calculate annually and target reductions of carbon emissions and greenhouse gases

- arising directly in Scope 1 & 2 from operations, through use of energy and gas in our buildings and fuel from our Truline delivery fleet.
- arising indirectly in Scope 3 from our operations and the provision of business supplies and services through key categories including but not limited to business travel, commuting, waste, upstream transportation, purchased goods and services, and water.

To monitor, manage and wherever possible reduce waste arising within our organisation maintaining a zero waste to landfill approach in our operations:

- through application of the waste hierarchy
- though regular reviews of waste streams to ensure recycling is maximised and general waste is minimised including:
  - working upstream with suppliers to reduce/reuse transport packaging where possible
  - o working cross-functionally to identify and eliminate wastes arising
  - o sourcing waste contractors who can assist in increasing recycling rates
  - o educating employees on the need to segregate wastes
  - o reusing materials wherever possible
  - ensuring any hazardous wastes arising from damaged/returned/end of life product such as Waste Electrical and Electronic Equipment (WEEE), batteries or cleaning products is minimised and disposed of correctly
  - o diverting usable end of life product to charitable or other causes

To monitor the use of water consumption on our sites to ensure usage remains at a consistent and low level.

To prevent air, water, ground pollution and accident, mitigating potential risks of harm to employees, customers and the environment through

• safe storage and packaging of goods
